

## **Norbec AIA Conference Contest Rules and Regulations:**

### **1. Eligibility:**

- The Norbec AIA Conference Contest ("Contest") is open to legal residents of the United States and Canada (excluding the province of Quebec) who are 18 years of age or older at the time of entry. Employees of Norbec and its affiliates, subsidiaries, advertising, and promotion agencies, and their immediate family members (spouse, parent, child, sibling, and their respective spouses) and household members are not eligible to participate in the Contest.

### **2. Entry Period:**

- The Contest begins at 9:45 a.m. Eastern Time ("ET") on June 6, 2024, and ends at 4:00 p.m. ET on June 7, 2024. Entries submitted before or after the Entry Period will not be eligible.

### **3. How to Enter:**

- To enter the Contest, eligible individuals must visit the Norbec booth (#2909) at the AIA Conference in Washington, D.C. during the Entry Period. Entrants must fill out and submit an official entry form provided by Norbec representatives at the booth to register for a continuing education training session ("Lunch and Learn") from Norbec. Only one entry per person is permitted.

### **4. Prize:**

- One (1) prize will be awarded in this Contest: a reMarkable 2 tablet. The total approximate retail value ("ARV") of the prize is 700\$ CAD. The prize is non-transferable, and no substitution will be made except as provided herein at Norbec's sole discretion.

### **5. Winner Selection:**

- The potential winner of the Contest will be selected in a random drawing conducted by Norbec representatives from all eligible entries received during the Entry Period. The drawing will take place within seven (7) days following the end of the Entry Period. Odds of winning depend on the number of eligible entries received.

### **6. Notification and Verification of Winners:**

- The potential winner will be notified by email and/or phone within seven (7) days following the drawing. The potential winner must respond to the notification within five (5) business days of the first attempt to contact him/her. If the potential winner fails to respond within the specified time period, he/she will be disqualified, and an alternate winner may be selected.

### **7. Publicity:**

- By participating in the Contest, entrants agree to allow Norbec to use their name, likeness, and/or prize information for promotional purposes without further compensation, except where prohibited by law.

**8. General Conditions:**

- Norbec reserves the right to cancel, suspend, and/or modify the Contest, or any part of it, if any fraud, technical failures, or any other factor beyond Norbec's reasonable control impairs the integrity or proper functioning of the Contest, as determined by Norbec in its sole discretion. In such event, Norbec reserves the right to award the prize at random from among the eligible entries received up to the time of the impairment.

**9. Release and Limitations of Liability:**

- By participating in the Contest, entrants agree to release and hold harmless Norbec, its affiliates, subsidiaries, advertising and promotion agencies, and their respective officers, directors, employees, and agents (the "Released Parties") from and against any claim or cause of action arising out of participation in the Contest or receipt or use of any prize, including, but not limited to: (a) unauthorized human intervention in the Contest; (b) technical errors related to computers, servers, providers, or telephone, or network lines; (c) printing errors; (d) lost, late, postage-due, misdirected, or undeliverable mail; (e) errors in the administration of the Contest or the processing of entries; or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use of any prize. Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Contest, and in no event shall the Released Parties be liable for attorney's fees. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.
